At Monday's hearing, Sgt. Eykel appeared alone. She noted that Mr. Service had left a message earlier that morning that he had removed Bear from King County and would not be joining the hearing. She noted that if Mr. Service provided contact information for the new owner and she can confirm the dog's status, that would satisfy the removal order (V23013936), and Animal Services would dismiss the more recently-issued violation notice (V23013935) and would not take enforcement related to the (alleged) February 14 trespassing.

We thus DISMISS Mr. Service's appeal of V23013905 (the violation stemming from the January 5 incident).

If for some reason we have misunderstood the situation, by **April 7, 2023,** either party is free to file, with the examiner, a motion for reconsideration explaining why the examiner should not be dismissing this appeal. Filing a timely motion for reconsideration postpones the deadline (described below the signature line) for lodging an appeal.
