At our abbreviated June 6 hearing, Animal Services noted that Ms. Richfield's then-recent efforts to contain Luscious had been successful in keeping Luscious off the complainant's property. The following day we entered an order staying our proceedings and noting that unless we heard from Animal Services within 90 days (i.e., by September 5, 2023) of another alleged incident, we would dismiss the violation without prejudice.

Having received no such notice, we dismiss violation notice V23014046 without prejudice (meaning our dismissal is not a decision on the merits).

If for some reason we have misunderstood the situation, by **October 9, 2023,** either party is free to file, with the examiner, a motion for reconsideration explaining why the examiner should not be dismissing this appeal. Filing a timely motion for reconsideration postpones the deadline (described below the signature line) for lodging an appeal.
