On June 20, we dismissed Ms. Wahchumwah's appeal after she failed to appear at our June 14 hearing or even to contact us afterwards to explain any reasons for her absence. On June 22, Ms. Wahchumwah informed us that she was "unable to participate because I had an unexpected surprise - a visiting with my grandmother, who is not from Seattle. I need to reschedule."

That is an insufficient ground for us to reopen the case. We DENY Ms. Wahchumwah's motion. That means Animal Services' April 17 notice and order, including the violation, \$1000 penalty, and the requirement that Fetti be muzzled when off the Wahchumwah's property, remains in effect.

This is our final word on the matter. If Ms. Wahchumwah's wishes to raise a further challenge, she may, by August 7, 2023, apply for a writ of review in superior court in accordance with chapter 7.16 RCW. We can offer no additional instruction beyond that; it is an appellant's responsibility to determine and meet the court's filing requirements.
