On June 22, we emailed and mailed our notice of hearing for yesterday's hearing. We received no communication in response. Mr. Davis did not appear yesterday. This constitutes abandonment of his appeal. We therefore DISMISS his appeal, which means both of Mr. Davis' pit bulls' viciousness designations and compliance orders remain in effect.

We realize that Mr. Davis is at the marginal end of things and may have had trouble making yesterday's hearing. If he would like to reschedule, we will retain jurisdiction over his case until **August 28, 2023**. He can email or call us (the examiner's phone and email are at the top of the previous page) through August 28.

The dogs, as we understand it, remain unlicensed. If Mr. Davis can get the dogs spayed/neutered, that reduces the annual licensing fee and may make the dogs less aggressive in the future. The Seattle Veterinary Outreach offers traveling clinics for those experiencing homelessness or are otherwise low income. https://www.seattlevet.org/calendar

In addition, one of the requirements for keeping a vicious dog in King County is that the dogs be microchipped. The Seattle Veterinary Outreach may be able to help with that as well. He can call them at 206-659-9810 to see what kind of services they can offer.
