Precious Laskowsky timely (given our deadline extension) requests that we reconsider our decision upholding Khaleesi's dangerous dog determination. She certainly put significant effort and careful thought into it. Yet, ultimately it does not change our finding that, more likely than not, on July 23 Khaleesi pulled Thor under the fence and killed him. We deny her motion for reconsideration.

We do however push back the compliance dates. Ms. Laskowsky now has until **January 10**, **2024**, to either:

- A. Follow the steps in exhibit D8 for obtaining a dangerous animal registration (steps 1-2) and thereafter follow the steps for keeping a dangerous animal (steps 3-4); OR
- B. Follow step 5 for rehoming Khaleesi; OR
- C. Surrender Khaleesi to Animal Services.

This is the examiner's last word on the case. It will become a final and conclusive decision unless, by **January 10, 2024**, either party applies for a writ of review in superior court in accordance with chapter 7.16 RCW.
