At our May 1 conference, Ms. Sharpe described disassembling the trailer and taking debris to the dump. Ms. Sawin noted that the latest round of dump vouchers provided to Ms. Sharpe would expire on June 7. Ms. Sharpe stated that she has been unable to take scrap to the recycler because (as of last week) it was not open. Ms. Sharpe asked that her compliance deadline be extended to August 31, and the Department agreed.

The Department's March 13 notice and order is sustained, except that the deadline for compliance is **August 31, 2020**. No penalties shall apply, so long as Ms. Sharpe meets that

deadline, or any reasonable extension to that deadline the Department grants. (We note that during Covid, things take longer than they would in normal circumstances.)

If for some reason we have misunderstood the situation, by **June 1, 2020,** either party is free to file, with the examiner, a motion for reconsideration explaining why the examiner should not be dismissing this appeal. Filing a timely motion for reconsideration postpones the deadline (described below the signature line) for lodging an appeal.
