Appellants Greg Davila and Maisie Starr did not challenge the bulk of the Department of Local Services' notice and order. After getting input at our August 18 prehearing conference, we issued an August 27 summary order upholding the violations, providing some explanation and steps forward, and setting compliance deadlines. We also retained jurisdiction, should a dispute arise in implementing that summary order.

On October 21, Appellants requested a thirty-day deadline extension. The Department does not object. Therefore, we MODIFY compliance deadlines as follows:

- 1. By October 31 November 30, 2020, Appellants shall remove (or store inside) accumulated rubbish, salvage, or debris.
- 2. By November 30 December 31, 2020, Appellants shall either submit to the Department a KCD-approved farm plan *or* remove all items from the property.
- 3. By January 31 March 2, 2021, Appellants shall either submit to the Department a complete permit prescreening meeting request for or remove items not directly tied to agricultural use and incorporated in the farm plan.

We continue to retain to reopen this case, should a dispute arise in implementing this summary order.
