In our February 2019 decision in ENFR170503 (construction, businesses, and grading), we retained jurisdiction. During a proceeding in ENFR190763 (sign) involving the same Appellants, counsel explained that there was a connection between ENFR170503 (a case apparently in the courts) and ENFR190763, and requested that we not yet close out ENFR170503.

We issued our decision in ENFR190763 in November and closed that out after the appeal period ran out in December. We emailed the parties on January 8, asking whether there was still a reason for us to retain ENFR170503 and, if so, why, and whether there was an endpoint or triggering step at which we should check back in. We asked for a response by January 12.

When we did not hear anything, on January 15, emailed again, setting January 20 as the deadline for submitting a rationale for us retaining ENFR170503 (and if so, an endpoint or triggering step at which we should check back in), and indicating that we would dismiss ENFR170503 if we did not hear anything.

Having still heard nothing, we thus DISMISS ENFR170503, terminating the Examiner's jurisdiction.

If for some reason we have misunderstood the situation, by **February 15, 2021,** either party is free to file, with the examiner, a motion for reconsideration explaining the above-requested information. Filing a timely motion for reconsideration postpones the deadline for lodging an appeal.
