On May 19, 2023, we went to hearing, closing the record on May 24. On June 13, we issued our Report and Decision.

On June 20, Appellants filed a Motion for Clarification. That motion was essentially premature, because an examiner decision only becomes the County's final determination once the period for filing a motion for reconsideration ends. Local Services timely filed a motion for reconsideration on July 5, asking us to reverse our decision. Local Services was within its rights to stay permit work until we ruled on its motion.

However, that posture changes today, because we deny Local Services' motion. That makes today's order, along with our June 13 decision, the County's final determination. Until such time as a court of competent jurisdiction enjoins our decision, Local Services must continue scheduling normal inspections on the Schmidt barn and home and must expeditiously resume the site plan review process from 2022.

As to a new end date, our assumption was that the year would run 12 months from our June 13 decision, as that was the date we ruled that Local Services had erroneously failed to renew the Schmidts' permit and that the Schmidts could resume work. However, as Local Services waited to continue permit processing until we ruled on its motion for reconsideration, the one-year permit extension starts running from today.²

This will be our final word on the matter.
