That became moot when Ms. Allen stated that she was withdrawing her appeal. She explained that they will not be conducting any more weddings until they can get a temporary use permit (TUP), which they will apply for after they legalize the clearing/grading. Ms. Allen explained that they have hired a consultant to analyze critical areas issues, but that will take some time.

The TUP permit application deadlines from the notice and order are moot, because the Allens are no longer hosting weddings. A TUP does not look backwards to try to legalize earlier events. So long as the Allens do not hold any additional events without a permit, they can proactively apply for a TUP on their schedule. We note only that because TUPs take a while to review, the Allens would want to get in a future application well before the wedding season.

A clearing and grading permit does look backwards to legalize or restore earlier work. We thus modify the notice and order on that score as follows:

Apply for and obtain the required permits, inspections, and approvals with complete application to be submitted by the following schedule:

- A. Submit a complete permit application by January 12, 2024.
- B. Meet all deadlines for requested information associated with the permit(s). Undertake no more clearing and grading until the permit(s) are issued.
- C. Pick up the permit within the required deadlines. Make any required corrections and obtain final inspection approval within 120 days of permit issuance even though the permit is good for a year.

If for some reason we have misunderstood the situation, by **November 6, 2023,** either party is free to file, with the examiner, a motion for reconsideration explaining why the examiner should not be dismissing this appeal. Filing a timely motion for reconsideration postpones the deadline (described below the signature line) for lodging an appeal.
