On September 15, 2025, Licensing issued Notice and Order For-Hire Permit Revocation to Dmytro Adamov. Ex. D2. Dmytro Adamov filed a timely appeal on September 24, 2025. Ex. D7. We went to hearing on November 17, 2025. Participating in the hearing were: Tyson Taylor representing Licensing, and appellant Dmytro Adamov. We provided a Russian interpreter for Mr. Adamov.

During Mr. Taylor's presentation of evidence for Licensing Services, Mr. Adamov indicated he did not want to pursue his appeal. We clarified on the record that Mr. Adamov wanted to withdraw his appeal of the revocation of his for-hire driver's permit. He confirmed through the interpreter that he wanted to withdraw his appeal and would no longer work as a taxi driver.

As the Appellant has withdrawn their appeal in this matter, the appeal is **DISMISSED**, with prejudice.

If we have misunderstood the situation, either party may email us a motion for reconsideration explaining why the appeal should not be dismissed. The motion must be received by **December 8, 2025**, or prior to any appeal deadline for judicial review, if applicable. If no motion is received, this Order of Dismissal shall be final and conclusive.
