On October 5, we issued a notice for a November 17 conference. The notice stated that Local Services would send the Chos and Mr. Lamb a link to the permit files by October 6, a deadline Local Services apparently complied with. We also set November 3 for a deadline for T&M or the Chos to file an amended or updated appeal statement. We were not necessarily expecting an amendment from the Chos, because their initial appeal statement was detailed.

In contrast, T&M's initial appeal statement was that it was waiting on records, and wished to file an amended appeal statement after reviewing those records (i.e., those Local Services ultimately sent on October 6). However, T&M did not file an amendment, either by the November 3 deadline or anytime thereafter. Nor did it notify anyone of the delay and ask to push back the conference until everyone could review its amended appeal statement. Thus, November 17 was essentially not a good use of everyone's time, as there were no T&M appeal issues for anyone to discuss.

We will give T&M one more chance to submit an amended appeal statement, this time by **December 1, 2023**. Email that to hearingexaminer@kingcounty.gov and to the parties listed above. If we do not receive anything by the deadline, we will dismiss T&M's appeal. Mr. Cho is welcome to file an amended appeal statement.

On November 30, we explained that we were pushing back our conference date by closing, in no uncertain terms, with:

As stated in our November 20 notice, the deadline for T&M to submit an amended appeal statement is December 1. We are not changing that deadline.

T&M did not file an amended appeal on December 1 (Friday). Nor did they belatedly file one on Monday or Tuesday or thus far on Wednesday.

We thus **DISMISS** T&M's appeal. We will proceed with the Cho appeal.
