Our October 2 report and recommendation erroneously repeated the traditional “Notice of Appeal” language. However, the code has recently been updated. The most substantive changes are that there is no longer an appeal fee nor a requirement to deliver a hardcopy of the appeal.

Our October 2 determination remains identical except that, any party may appeal that by following the steps described in KCC 20.22.230, including, by **4:30 p.m.** on **November 6, 2023**, emailing an appeal to Clerk.Council@kingcounty.gov, to hearingexaminer@kingcounty.gov, and to the rufusmsprague@gmail.com, thesherers@comcast.net, dmgrosco@comcast.net, leslie.drake@kingcounty.gov. Please consult KCC 20.22.230, for the exact requirements.

If a party fails to timely file the appeal, the Council does not have jurisdiction to consider the appeal. Conversely, if the appeal requirements of KCC 20.22.230 are met, the Examiner will notify parties and interested persons and will provide information about next steps in the appeal process.
