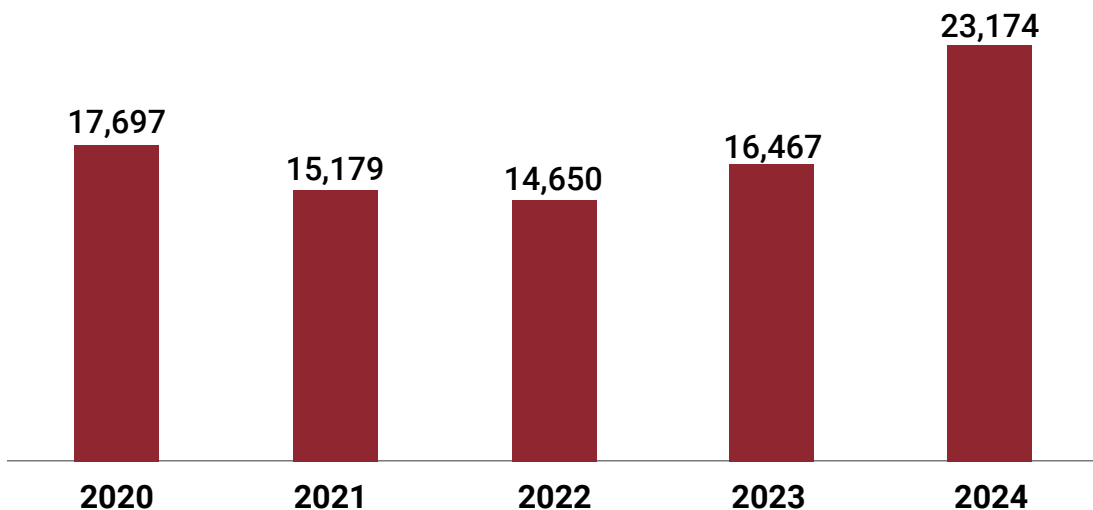

Ci jamonoy mbas mi COVID-19, réew yu bari dañu wàññi sàrti dem bi ak dikk bi ndax oto yi dañu gëna néew ci tali yi, te kàngam yi ci wàllu wérgi-yaram dañu digal ñu wàññi jokkoog nit ñi.⁵ Doxalal yooni dem bi ak dikk bi ci Komte bu King toppnañu lu mel noonu, ak limu taxawalug dem bi ak dikk bi di wàññeeku ci 2020 ba 2022 ginaaw ga mu yokk lu tollu ci 40% diggante 2023 ak 2024.⁶

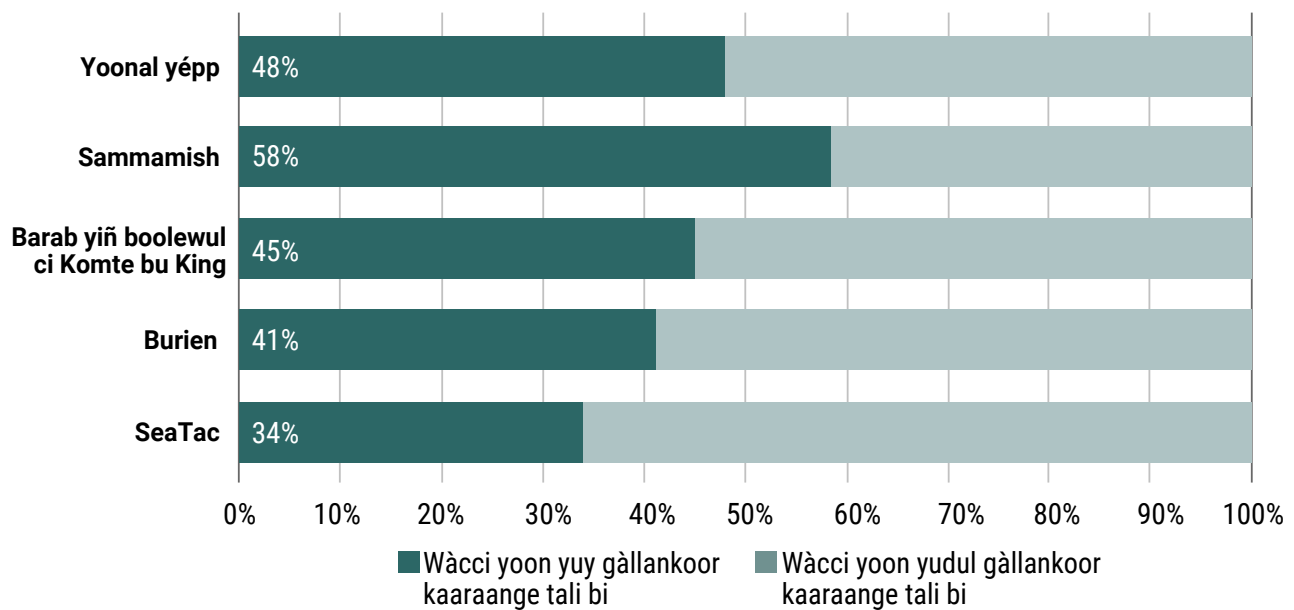

Loolu dafay tekki ni Biro Shérif bi mënul xoolaat wuute yi mëna am ci taxawal yi.⁶¹ Biro Saytukat bi dafa digal Biro Shérif bi mu dajale ay done demografik yuñ gis ci bépp taxawal trafic, ak lu mëna nekk sabab taxawal bi wala njeexital bi.

Ndawi Biro Shérif bi dañu fësal yenn xalaat ak tiis ci bind xibaar yiñ gis ci demografik ci jamonoy taxawalug dem bi ak dikk bi. Jafe-jafe yi bokku na ci lu mëna ñàkka dëggu, ñàkka mëna jëfandikoo, ak lu mëna yàq diggante depite yi ak dawalkat yi. Doxal yoon ci anam wu otomatik mën na yokk wuute gi am ci wàllu race ak koom ci doxalal yoon ci dem bi ak dikk bi. Dañuy faral di def kamera yi ci koridoor yu gaaw yi, yu nekk ci dëkkuwaay yu bari askan, yu bari ay nit ñu ñuul ak ñi am xalis bu néew.⁷³ Kon amande yi bawoo ci bindal nit këyit ci tali yi ñoo gëna mëna gállankoor dawalkat yu ñuul yi ak dawalkat yu am xalis bu néew yi mën nañu am jafe-jafe fay leen.⁷⁴

Njàngat ci mëna dem ak yamale dafa wara am ci ab agence bu moom boppam ci Biro Shérif bi, ñu defar ko ci jàppante ak askanu dëkk bi ci biir jurisdiksiyon bi, ngir mëna wax ni askan wiñ laal am xëcc bu doy ngir joxe seeni xalaat ak seeni xalaat ci liggéey bi yépp.

4.2 Bépp pexe ëlëg ngir amal yeneen sàrt yuñ tëral ci otomatik dafa wara nekk ci ndigalu askan wi, ba noppi ñu bàyyi seen xel ci saafara jafe-jafe yi ci wàllu kaaraange ci dem bi ak dikk bi.

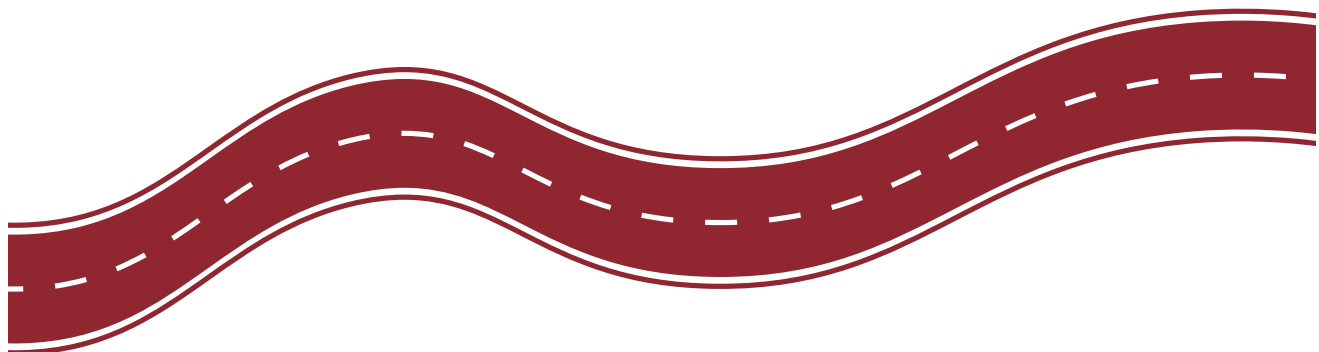
